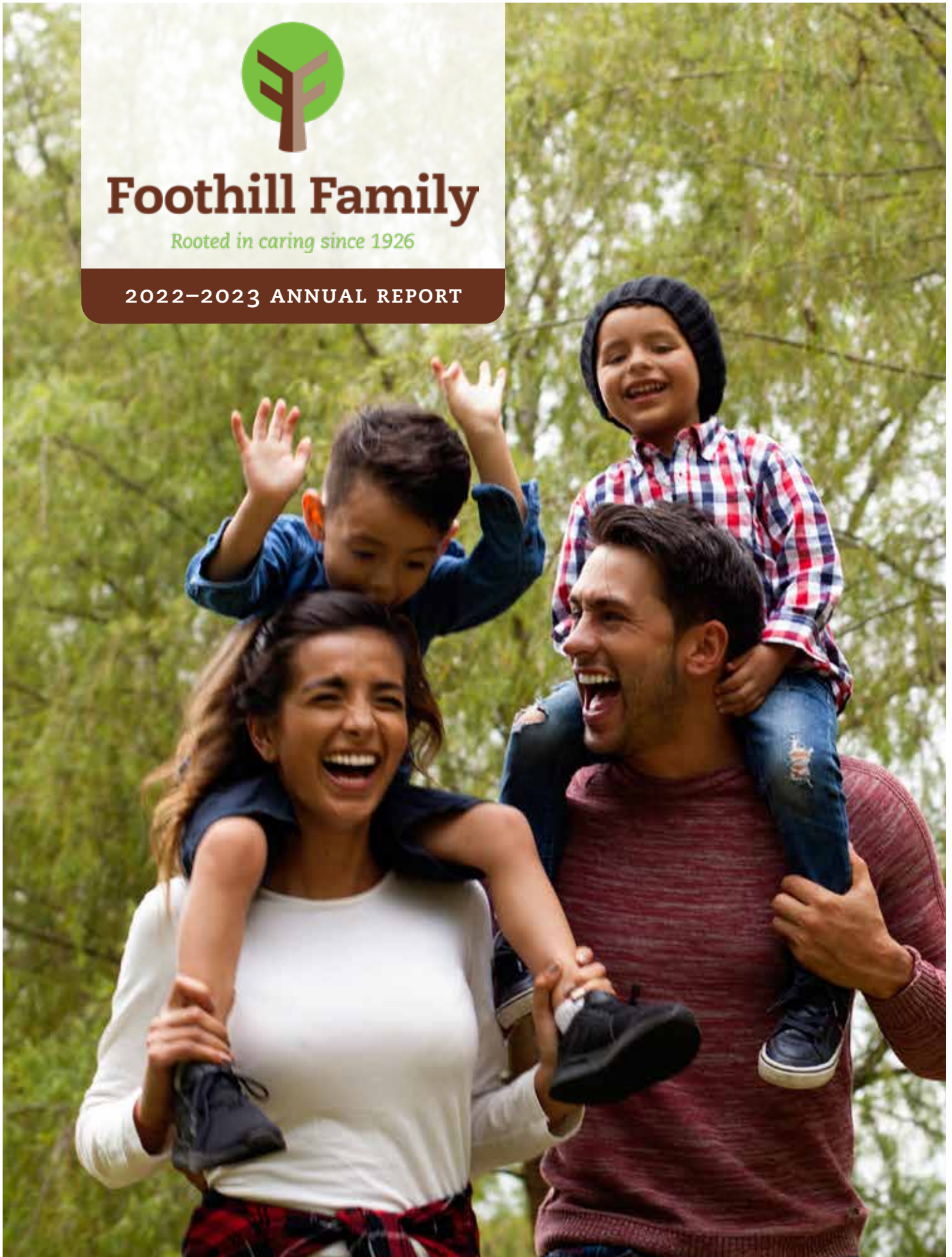

For nearly 100 years, Foothill Family has led the way in providing comprehensive mental health and social services throughout the San Gabriel and Pomona Valleys, Glendale, and Burbank, through the following key programmatic areas:



Mental Health Care

Foothill Family provides effective mental health assessment and treatment for children and adults, individuals and families.

Early Childhood Development

Foothill Family's zero to five programs provide parents/caregivers and their young, high-needs children with essential early intervention, detection, and prevention strategies and tools during their child's critical developmental years. Services include parent education and can address autism spectrum disorder and/or other developmental delays.

School-Based Services

Currently providing services in 18 school districts in Southern California, Foothill Family provides assistance to children and youth exhibiting social and/or emotional challenges in order for them to succeed at school, at home, and in their communities. Our programs include teacher trainings and promote school community development alongside school/family engagement.

Youth & Family Services

Foothill Family launches families on healthy journeys by providing mental health treatment for children and their caregivers, as well as treatment and support services for victims of abuse, neglect, and/or domestic violence. Also, case management and mentoring programs help pregnant and/or parenting youth to attend school and graduate, raise healthy babies, and learn positive parenting skills.

His grantmaking strategy was based on the belief that the formative years from prenatal to preschool age are the most important. In 2010, he helped to found the Brighter Futures Council as a way to provide sustainable funding for the most effective work we do, assuring the best start to the lives of vulnerable children aged 0-5.

Members of this council were dedicated to spreading the word about Foothill Family's special area of expertise in working with children before birth and up to age five.

Richard valued giving, sharing, and changing lives, and he left an unforgettable impact on our clients and families.



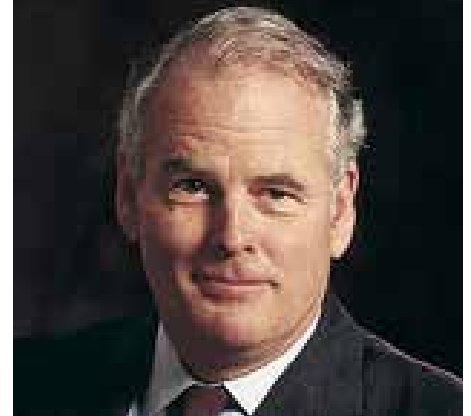
William H. Hurt

donor SPOTLIGHT

Practicing in the heart of Pasadena, **Dr. Jean Lauricella**, a pediatrician with four decades of experience, combined her medical expertise with her passion for community service. Dr. Lauricella's (fondly known as Dr. Jean) philanthropic journey with Foothill Family, an organization she has fervently supported for 30 years, has guided her through many leadership roles within the agency.

Her involvement started with a meeting with Frank Tranzow, Foothill Family's board chair, who recognized Dr. Lauricella's talent, enthusiasm, and deep ties to community engagement. Following this meeting, Dr. Lauricella spearheaded initiatives that engaged donors and bolstered community support including the Benefit & Auction and forming a community volunteer group, a precursor to the Friends of Foothill Family women's group which is still active.

"Dr. Jean's dedication to Foothill Family and children of our community over the last three decades is beyond measure," stated Vanessa Wolf Alexander, who volunteered alongside Dr. Lauricella as a teen. "Dr. Jean was a fundraising powerhouse—bringing in families by the dozens for an annual Stroll-a-thon around the Rose Bowl and single-handedly spearheading the benefit for years before the founding of the Friends of Foothill Family."

Reflecting on her foundational role, Dr. Jean remarked, "It's fantastic to see Foothill Family's growth, and I feel proud to have been a stepping stone or an original stone for you."



"Over the years, my patients have been very generous with Foothill Family. I felt that it was such a good cause and I could talk to them about how their scope was so inclusive from infancy, to teenage moms, to parenting skills, to challenges teens face."

She found particular joy in witnessing success stories, notably the graduations of pregnant teenagers who thrived with the support of Foothill Family.

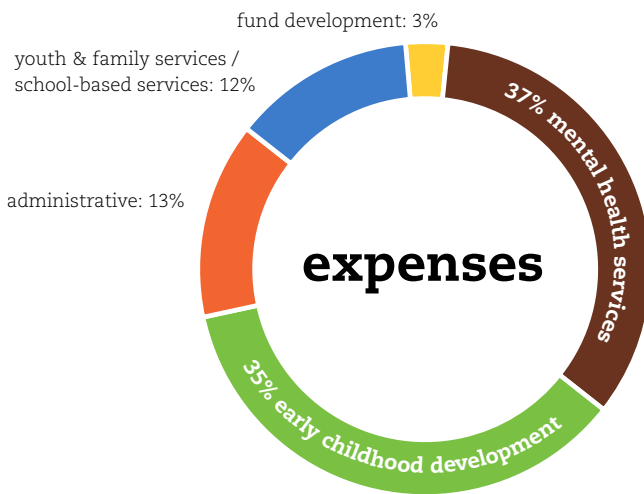
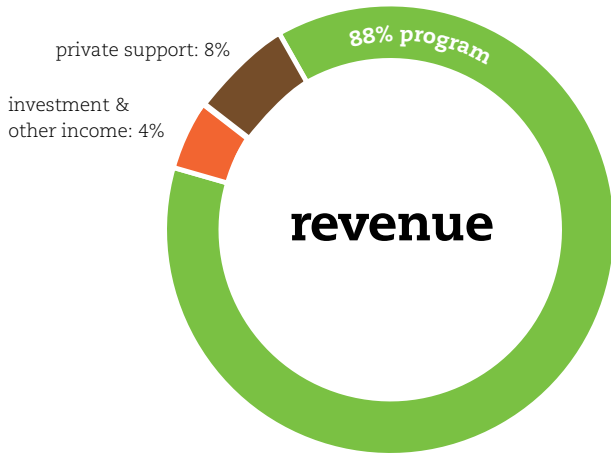
